The Supreme Court of Canada ruled in favour of a developer, Dell Holdings, recovering the damages from the imposed delay in the development of certain lands which were identified and subsequently acquired as a GO station site. The presentation by the counsel for Dell and the appraiser who gave evidence of the losses suffered will examine the factual background of the case, explore different methods of quantification of such losses, and analyse the implications of the decision.
